

Minutes of the Regular
Scheduled Meeting
Troup City Council
November 20, 2017

A Scheduled Meeting of the Troup City Council was held Monday November 20, 2017 at 6:30 pm at the Cameron J-Jarvis Troup Municipal Library located at 102 S. Georgia, Troup, Texas. Councilpersons present were: Mayor Joe Carlyle, Jeff Hale, Nelson Darden Jr., Chip Richardson and Carole Wilson. Also present were Police Chief Pat Hendrix and City Secretary Buffie Deason.

Mayor Joe Carlyle called the meeting to order at 6:33 p.m. noting all Council members were present. Guest present were Caleb Vierkant and Michelle Dillon.

Chip Richardson led the invocation.

Chip Richardson led the Pledge of Allegiance.

Mayor Joe Carlyle – Item 4 Consider approval of the minutes from the Regular Scheduled Meeting of October 16, 2017. This item was tabled.

Mayor Joe Carlyle – Item 5 Citizen Comments- Brief Comments concerning non-Agenda items. No comments made.

Mayor Joe Carlyle- Item 6 Review and consider the city financial report for the month of October 2017. Council was presented with October financial. Councilperson Nelson Darden made the motion to accept the October 2017 financials. Councilperson Carole Wilson seconded the motion and the motion carried unanimously.

Mayor Joe Carlyle – Item 7 Comments, questions or input from City Manager’s written report. There was not a manager’s written report. Chief Hendrix presented Council with the Police Monthly report.

Mayor Joe Carlyle – Item 8 Discuss and consider adopting Resolution No. 2017-1120-01R “A RESOLUTION ADOPTING THE 2018 SMITH COUNTY HOLIDAY SCHEDULE EXCLUDING THE ADMINISTRATIVE DAY FOR THE CITY OF TROUP.” Councilperson Chip Richardson made the motion to adopt Resolution No. 2017-1120-01R. Councilperson Jeff Hale seconded the motion and the motion carried unanimously.

Mayor Joe Carlyle – Item 9 Discuss and consider approving the final plat of Deese Addition to The City of Troup a part of The William George Survey A – 1099 Smith County, Texas. Councilperson Carole Wilson made the motion to approve the final plat of the Deese Addition. Councilperson Jeff Hale seconded the motion and the motion carried unanimously.

Mayor Joe Carlyle – Item 10 Discuss and consider a Zoning Change request for Lot 2 of the property located at Tract 15 Abst A 1099 of the Williams George Survey Map (703 W. Ross). The request is to change the Zoning from Single Family Residential 1 to Manufactured Home Zoning. Councilperson Jeff Hale made the motion to change the zoning on lot 2 of the property located at Tract 15 abst A1099 of the Williams George Survey Map from Single Family Residential to Manufactured Home Zone. Councilperson Nelson Darden seconded the motion and the motion carried unanimously.

Mayor Joe Carlyle– Item 11 Discuss and consider approving Resolution No. 2017-1120-02R to approve the sale of struck off tax property Cause No. 24,630-B. Councilperson Jeff Hale made the motion to approve Resolution No. 2017-1120-02R. Councilperson Nelson Darden seconded the motion and the motion carried unanimously.

Mayor Joe Carlyle – Item 12 Discuss and consider A RESOLUTION #2017-1120-03R IN ORDER TO CAST VOTES FOR THE BOARD OF DIRECTORS OF THE CHEROKEE COUNTY APPRAISAL DISTRICT. Councilperson Nelson Darden made the motion to approve Resolution No. 2017-1120-03R casting the City’s vote for Chester Pond. Councilperson Jeff Hale seconded the motion and the motion carried unanimously.

Mayor Joe Carlyle – Item 13 Discuss and consider the approving the Racial Profiling Report of the Troup Police Department. Chief Pat Hendrix presented Council with the profiling report. Councilperson Jeff Hale made the motion to approve the Racial Profiling Report. Councilperson Carole Wilson seconded the motion and the motion carried unanimously.

Mayor Joe Carlyle – Item 14 Discuss agenda request by Layne and Karon Bonnet about the de-annexation of the property located at 22498 CR 2144 legal description Tract 89 of ABST A1099 W George. Mayor Joe Carlyle told Council that this was the second request and that the first request was denied. Councilperson Chip Richardson made the motion to deny the request for de-annexation by the Bonnets. Councilperson Jeff Hale seconded the motion and the motion carried unanimously.
